    - 1. Executive Director Andrew Dolloff was appointed interim executive director at a stipend of \$3000, pro-rated from the start of the year (July 1) to the date on which a new executive director is named. (Motion: Steve Connolly, Second: Steve Marquis, Vote: 7-0-1

  - B. Funding
- 1. FY 19 Budget Close-out A balance of \$97,824.24 was reported
- 2. Income/Expense report
  We will receive \$9,850 from the state and pay \$2,295 for insurance, moving our balance on hand to \$105,379.24
- 3. FY21 Budget
  A preliminary budget was presented, showing a carry-forward of
  \$34,040. With Doe direct funding of \$23,410 and an additional \$1000 in
  member assessments, this results in \$58,450 of revenue. Projected
  expenditures are of an equal amount.

#### 5. OLD BUSINESS

A. Spirit Series – Steve Connolly presented information on the costs and benefits of this program.

From January 2020 to June 2021, 14 residencies can be provided (5 in 2020, 9 in 2021) at a cost of \$25/seat to the RSC and \$25/seat to the local district (regular cost \$105/seat), due to a grant of \$6,875 from the state. Members will speak with their elementary principals to determine the desire for such programming.

Ladies and Gentlemen:

We were asked to review the internal controls and examine the details of revenues and expenditures for Southern Maine Regional Service Center (SMRSC) as part of the audit that we performed for Regional School Unit No. 21 (RSU 21). RSU 21 is the fiscal agent for SMRSC. We reviewed the period of July 1, 2018 through June 30, 2019 for SMRSC.

This being the first year of SMRSC, there were a limited number of transactions. Total revenues were \$115,533, consisting of \$97,200 received from the State of Maine Department of Education and \$18,333 received from the 10-member school districts and total expenditures were \$17,709 resulting in an ending fund balance of \$97,824.

Our review of internal controls did not identify any deficiencies in internal control or other matters to bring to your attention.

Our examination of the details of revenues and expenditures did not identify any transactions that appeared to be unusual or improper. All transactions that we examined appeared to have been properly accounted for and had proper supporting documentation.
